









Mandate and Publications

- Flyways Resolution 12.11 (Rev. COP13)
- Decisions 13.41 to 13.46 on Flyways
- Migratory Birds and Flyways POW (2014-2023)
- StC's Report on the Implementation of its POW 2020-2023 (CMS StC, 2022)

Flyways Working Group (FWG)

Suffered from capacity issues and a very ambitious POW

CMS Flyways strategic review 2022-23

- FWG meeting February 2023
- Renewed membership and chair
- Renewed objectives, linked to new SPMS
- Clear need to link AEMLAP, Raptors MOU, CAF and other non-CMS instruments (AMBI, EAAFP..)
- Willingness to play global role on flyway-related work within and outside CMS instruments


- Resolution 11.17 (Rev.COP13)
- AEMLAP aims to improve the conservation status of all migratory landbirds through international and national action.
- Jointly coordinated by CMS & and coordination unit at Swiss Ornithological Institute (SOI)
- Just finished a review of AEMLAP Programme of work (POW 2021-2026)
 - It includes many actions ready to be implemented with clear links to Raptors MOU objectives in the African-Eurasian region.

The CAF in 2023

- Agreement to define an institutional framework: the CMS Central Asia Initiative
- Agreement to update the CAF Action Plan and benefit from BLI Situation Analysis
- Government of India willing to host CMS-CAF Secretariat
- A key region for both Raptors MOU, AEMLAP and other CMS and non CMS instruments
 - Need to ensure synergies

2011

 Preventing Poisoning Working Group established

2014

 Resolution 11.15 – adopting Guidelines for all ammunition phase-out by 2017

2017

 Resolution 11.15 (Rev COP12) – mandate for UNEA to consider this issue

2020

 Resolution 11.15 (Rev COP13) – mandate for Intergovernmental Task Force on Phasing Out Lead Ammunition and Lead Fishing Weights





Key activities

- Defined ToR Lead Task Force in 2021
- Guinea-Bissau workshop on Vulture Poisoning (VCF) in May 2022
- Promoted issue across UN agencies & stakeholders and all CMS comms channels
- Supported work of Expert Group for the Evaluation of Exposure of EU Birds to Lead, thanks to voluntary work of members of PPWG









- 1. REACH Restriction on lead shot in wetlands
- REACH Wider restriction lead ammunition & fishing weights





EU ECHA recommendations

	Ban on placing on the market	Ban on use
Gunshots	✓	~
Bullets	×	✓
Conditional Optional Derogation (Commisssion to decide)		
Use in outdoor shooting ranges at designated/permitted areas with >90% lead recovery.		

Transition periods at present:

- a) Shot: originally 5 years final decision likely to be much shorter
- b) Bullets: 18 months for large calibres
 - **5 years** for smaller calibres (TBD)





Next steps

Continue to monitor and support ongoing process in EU and beyond and

- Gather members for the Lead Task Force
- Call for a first meeting and define Programme of Work
- Learn from EU experience and push for similar lead ban worldwide
- Coordinate with key stakeholders such as UNEP, Basel Rotterdam and Stockholm convention, Olympics Committee, NGOs, Academia
- Push for National Action Plans on phasing out lead ammunition
- Encourage parties to monitor implementation of measures







- Res 11.16 (Rev.COP13) <u>The</u>
 <u>Prevention of Illegal Killing, Taking</u>
 and Trade of Migratory Birds (IKB)
- Decisions 13.27-13.31
 - Task Force on Illegal Killing, Taking and Trade of Migratory Birds in the Mediterranean (MIKT);
- Decisions 13.32-13.33
 - Task Force on <u>Illegal Hunting</u>, <u>Taking</u> and <u>Trade of Migratory Birds in East</u> <u>Asian- Australasian Flyway</u>.

- MIKT proves international cooperation yields results against IKB
- ITTEA launched to replicate model in EAAF
- Mandate provides framework for further regionally-focused task forces



ITTEA – Asia Pacific Illegal Taking Task Force





- Launched in Brisbane, Australia, in March 2023
- Approved Modus Operandi and Draft Programme of Work focused on
 - understand the scope, scale and motivations behind taking and trade of migratory birds
 - develop national legislative frameworks on illegal taking of birds
 - establish active in situ prevention by stakeholders
 - establish a sustainable funding base for countries and stakeholders.
- Workshop on Market surveys planned for August 2023 (online)
- Working alongside EAAFP and other key stakeholders to address this threat

South-West Asia Illegal Taking Task Force

- Resolution 11.16 (Rev.COP13) provides mandate "to support efforts to address IKB elsewhere in the world"
- October 2021
 - CMS & BLI organised workshop in Jordan to developing a road map to tackle IKB in South-West Asia.
 - Decision to move forward to design an action plan to eradicate illegal taking and trade in the region.
- Concept note and fundraising brief developed outlining next steps to establish a mechanism for the delivery of the Action Plan for the region.
- CMS currently discussing with Parties in the region options for setting up this new Task Force.



Impact of use of wild meat

In response to Decision 13.64, CMS has launched a consultancy to understand the use of avian wild meat of CMS-listed bird species

Focus on African-Eurasian flyways

Objective is to quantify impact and enable Parties, policy instruments and NGOs to set appropriate priorities to address the issue.

Interested individuals/organisations encouraged to apply

Full coordination with AEMLAP, Raptors MOU and other relevant CMS instruments

Strategic Plan for Migratory Species

- Resolution 11.02 (Rev. COP12) defined 2015-2023 SPMS
- 2022 StC53: discussed way forward and agreed to create IWG on SPMS
- 2023
 - Broad consultation of new SPMS 2024-2032 draft
 - IWG to submit draft to StC
 - End of July: StC to submit draft SPMS to COP

- Six goals and specific targets
- Focus on
 - Species, Habitats, Threats, Science and Capacity building, Governance and Synergies
- To be discussed and approved at COP14
