

Summary:

This document provides guidance for the development and implementation of National Action Plans (NAPs) against the illegal killing, taking and trade of wild birds (IKB). This activity implements Action a) under the objective National IKB Action Plans and the 2030 target "National Action Plans are developed and adopted and are being implemented in all countries" of the Rome Strategic Plan on Eradicating Illegal Killing, Taking and Trade in Wild Birds in Europe and the Mediterranean region 2020-2030.

MIKT members and the Standing Committee of the Bern Convention endorsed this document.

Summary:

During the Joint meeting of the Bern Convention Network of Special Focal Points on Eradication of Illegal Killing, Trapping and Trade in Wild Birds and the CMS Intergovernmental Task Force on Illegal Killing, Taking and Trade of Migratory Birds in the Mediterranean held virtually from the 9th to the 11th of June 2021, the Secretariats presented a discussion paper on baseline and methodology for assessing progress toward achieving the Rome Strategic Plan 2020-2030. Following the Joint meeting, a written consultation has been held to gather additional ideas and viewpoints from participants to the Joint meeting. The present document is based on the results of the discussion held during the meeting and the feedback received in writing afterwards.

The MIKT Members are recommended to endorse the paper and Bern Convention SFPs are invited to support the submission of the document for its possible endorsement by the 41st Standing Committee of the Bern Convention.

Summary:

This document is designed to support MIKT members and Bern Convention SFPs in conceiving and implementing their national surveys / assessments of the motivations, drivers and modus operandi behind the illegal killing, taking and trade of wild birds (IKB), facilitating their delivery of Objective 1.2b of the Rome Strategic Plan on Eradicating Illegal Killing, Taking and Trade in Wild Birds in Europe and the Mediterranean region 2020-2030 (RSP). The document comprises guidance on the use of social science to understand the motivations behind IKB (including relevant case studies), a step-by-step guide for conducting a social study on IKB and a suggested format for reporting on a national survey/assessment.

A first draft of this document was presented in UNEP/CMS/MIKT5/Doc.7.2/Rev.1 Draft / T-PVS/Inf(2022)20rev: Methodology, Guidance and Common Format for Conducting Socio-economic Research into the Motivations behind IKB. The first draft was discussed at the Joint Meeting of the Bem Convention SFPs and CMS MIKT on Illegal Killing, Taking and Trade of Wild Birds – Valencia, Spain and Online Meeting (MIKT5) and presented to the Bern Convention 42nd Standing Committee meeting. Following two rounds of consultation and the integration of received comments, the present document was prepared.

MIKT members have endorsed the document. As per decision of the Bern Convention Standing Committee at its 42nd meeting, the final version of the document will be presented for discussion to Standing Committee at its 43rd meeting.



Intergovernmental Task Force on Illegal Killing, Taking and Trade of Migratory Birds in the Mediterranean



The Intergovernmental Task Force on Illegal Killing, Taking and Trade of Migratory Birds in the Mediterranean (MIKT) has been convened by the CMS Secretariat in conjunction with the Secretariat of AEWA, the Raptors MOU Coordinating Unit and the African-Eurasian Migratory Landbirds Action Plan (AEMLAP) Working Group. It brings together governmental representatives of CMS Parties from the Mediterranean region, including European Union Member States, and other interested Parties. Representatives from non-CMS Parties as well as relevant international organizations and networks are also part of MIKT as observers..

As of September 2022, the Membership of the Task Force consists of 22 CMS Parties. Additionally, three Interested Parties (CMS Parties which do not have a Mediterranean coast), and one Non-Party are Observers to the MIKT. Twelve multilateral environmental agreements (represented by their Secretariats), organizations and networks, and nine non-governmental organizations (NGOs) are Observers to MIKT. The Rome Strategic Plan 2020-2000: Eradicating Illegal Killing, Taking and Trade in Wild Birds in Europe and the Mediterranean region is the strategic framework for the

It was developed during a Joint Meeting of the Bern Convention Network of Special Focal Points (SFPs) on Eradication of Illegal Killing, Trapping and Trade (IKB) in Wild Birds and the CMS MIKT in May 2019 in Rome.

The overarching long-term goal of the Rome Strategic Plan is the eradication of IKB within the geographic scope of the Bern Convention and MIKT. The goal of the Rome Strategic Plan for 2000 is a 50% reduction of the scale and scope of IKB compared to a 2020 baseline.

MIKT members adopted the Rome Strategic Plan as it was adopted by the Bern Convention Standing Committee in December 2019, with the clear understanding that a detailed and ambitious workglan would be developed for specific actions to be implemented by MIKT Members and Observers in the Mediterranean.

The Rome Strategic Plan, was developed as a conf.

2016, 2020 which ended in 2020. The MIKT Workplan for the period 2021-20 fully aligned with the Rome Strategic Plan, was developed as a conf.




